**Hours:** The Swap Meet will be open to the public Saturday, March 8<sup>th</sup> from 7am to 3pm. Vendor setup will be Friday evening March 7<sup>th</sup> from 4 pm to 7 pm and Saturday morning from 6:30 am to 8 am.

**Location:** Howard County Fairgrounds, 2210 Fairgrounds Road, off MD Route 144, West Friendship, MD 21794.

<u>Directions</u>: From Baltimore, west on I-70 to MD 32 (Exit 80). Head south on MD 32 and then west on MD 144, following the signs for the Howard County Fairgrounds.

<u>Vendor Spaces</u>: Indoor spaces are approx. 100 sq. ft. (10 ft. x 10 ft;) (some spaces may vary in shape) Cost is \$40. Covered spaces are approx. 10 ft. x 15 ft. and cost \$35. Outdoor spaces are approx. 10 ft. x 40 ft. and cost \$40. Car Corral spaces (for vehicles age 20 years or more) are \$25 for each vehicle.

<u>Conditions</u>: Space only is supplied. Vendors must supply their own tables, chairs, etc. Vendors are required to leave spaces clean. All materials and trash must be removed at the end of the Swap Meet.

<u>Swap Meet will be held regardless of weather</u> <u>conditions</u>. Therefore, money paid for reserved spaces is not refundable.
